❖ To mitigate the threat of the COVID-19 (Coronavirus) to the Citizens of Meagher County, the following measures and services have been put into place:

- **3-17-2020 Meagher County declares a Local State of Emergency**
- **3-20-2020 City Of White Sulphur Springs declares a Local State of Emergency**
 - Declaring a local emergency is a procedural tool to aid in the response to the COVID-19 outbreak and related closures. The declaration also allows the City and County the ability to apply for federal reimbursement for certain expenditures related to the disaster, if money becomes available in the future.
- **3-20-2020 Governor Bullock issues Executive Orders 2-2020 and 3-2020 declaring that a state of emergency exists in Montana due to the global outbreak of COVID-19 Novel Coronavirus.**

- The Clinic is operating M-F and offering telemedicine visits (547-3321 for appointments)
- If you feel ill and may have been exposed to the Coronavirus, please *DO NOT* COME directly to the hospital or clinic. First call one of the following numbers for screening.

- All emergency and clinic patients will use the Clinic entrance
- Mentalhealth visits call 547-3888
- Mountainview Medical Center has a “NO Visiting” restriction in place for the entire facility

Reasons to come directly to the hospital include:

- Any emergencies *not* related to Coronavirus
- Uncontrolled fevers
- Shortness of breath
- Severe dehydration
- Other complicating diseases such as; COPD, emphysema, or any other respiratory disorder

CITY OF WHITE SULPHUR SPRINGS

- City Hall closed to the public
- City Clerks (547-3911) and City Judge (547-3634) are available by appointment only
- The residents within the city may notice an increased smell or taste of chlorine in the water, ***THIS IS NOT DUE TO COVID-19***. It is normal routine to build up the residual in our farthest reaches of water main.

Be a Good Friend and Neighbor
